A reference is made to which financial conglomerate the sub-group is part of. Where the Member State/ECB has opted according to Article 5 (2) of Directive 2002/87/EC not to supervise a sub-group as a financial conglomerate, as it considers that the sub-group is part of another financial conglomerate to which the FICOD applies, the sub-group has not been included in the list.

³ The list includes groups for which a waiver, either in full or in part according to Article 3 or 3a of Directive 2002/87/EC applies. Where Article 3.3 or Article 3.3a, resp. of Directive 2002/87/EC applies, the relevant competent authorities have decided by common agreement not to regard the group as a financial conglomerate or, instead, the group in question has been identified as a financial conglomerate, but the coordinator and, where appropriate, the relevant competent authorities have decided that the group should not be subject to all requirements of supplementary supervision as required under Directive 2002/87/EC.
